Please be advised that no ground disturbing activities have occurred on the location. QEP does not believe that stakes remain in the ground from staking activities that occurred in approximately 2007. QEP respectfully requests that the well be removed from the AFMSS database in addition to being removed from Nationwide bond No. ESB000024.
