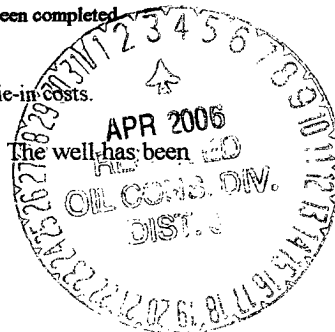

On 1/25/06 a new separator and test meter w/ back pressure regulator was manifolded in to determine flowrate (if any). The well has been pumping fluid to the production tank and venting gas since approx. 2/7/06. Currently the well is venting ~ 3 mcf/d.
