WPX Energy requests authorization to flare the Chaco 2308-04P #406H if a potential cross flow event may occur as a result of a nearby Frac activity on **Logos #5**. If a cross flow event on the well results in nitrogen content above Williams pipeline standards, flaring may begin as soon as **12/14/16 for 30 days**, given approval.
