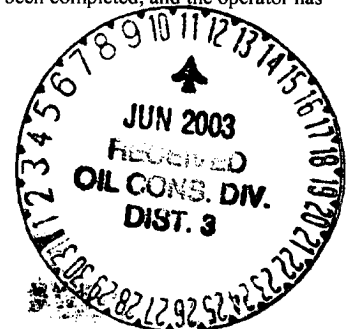

The wellbore will be cleaned out to plug back total depth. All formations will be commingled using a single string of tubing. A down hole commingle application will be submitted for approval.
