


13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleat horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. Attach the Bond under which the work will be performed or provide the Bond No. on file with BLM/BIA. Required subsequent reports must be filed within 30 days following completion of the involved operations. If the operation results in a multiple completion or recompleat in a new interval, a Form 3160-4 must be filed once testing has been completed. Final Abandonment Notices must be filed only after all requirements, including reclamation, have been completed and the operator has determined that the site is ready for final inspection.

The Florance 096 well API 30-045-11756 was plugged and abandoned on 7/28/2006. As of 8/9/2016 BP has completed reclamation work to include equipment removal, re-contouring, temporary fencing and seeding of location. On December 1, 2016 Sabre Beebe, BP and Randy McKee, BLM performed a site visit to evaluate the reclamation work performed. Mr. McKee approved all work performed on location and agrees the location is ready for monitoring of re-vegetation. During site visit it was noted that the P&A marker needs to have the API and Lease number added onto the marker. BP will address this issue.
