

The Jones A LS 009 well API 30-045-21267 was plugged and abandoned on 8/22/2002. As of 10/11/2016 BP has completed reclamation work to include equipment removal, re-contouring, and seeding of location. On December 20, 2016 Sabre Beebe, BP and Randy McKee, BLM performed a site visit to evaluate the reclamation work performed. Mr. McKee approved all work performed on location and agrees the location is ready for monitoring of re-vegetation. During the site visit a dog leg belonging to BP was noted and if this line is no longer in service and can be removed BP will address this issue.
