In reference to the phone conversation with William Tambekou in December 2016, SGI requests a delay for a production test on the subject well. This is a CBM well that is in the De-Watering phase and makes little to no gas with no existing pipelines for water takeaway. The well has to run initially on propane and the water has to be trucked to a disposal facility. Due to the remote location and existing rough winter conditions we request that the required production test for the subject well, (previously submitted for a "commercial shut-in gas well" determination), be postponed until road conditions permit a proper test without freezing potential and possible water spills and accompanying road damage. The test will be performed as soon as spring road conditions permit.
