XTO Energy Inc. received verbal approval on 03/08/17 from Jack Savage/BLM @ 9am and from Brandon Powell/NMOCD @ 10:15am to perform a casing repair on this well. XTO found and confirmed a casing part on this well at 42' depth from surface, during rod pump repair work with a workover rig. To repair the parted casing (42' of 4-1/2" has already been removed from the wellbore to verify the issue), XTO plans to:

1. Internally cut the 4-1/2" casing just below the part depth to remove the remaining casing threads, with a mechanical cutter.
2. Dress the top of the 4-1/2" casing that is looking up to prepare for casing patch.
3. Run in hole and set a 4-1/2" casing patch assembly and 4-1/2" casing to surface
