DJ Simmons, Inc. notes there has been some discrepancy about who is the current lessor. Resolution has been sought to determine the mineral lessor for this well. Considering the above, DJ Simmons, Inc. respectfully requests Continued Shut-In status for the subject well for the following reasons:

- The well equipment was tested as late as November 2013.
- Last sustained production was 45 MCFD and 4 BWPD. Gas prices and production costs render the well uneconomic.
- There are reasonably recoverable reserves left.
- The well is equipped and ready to run using pump jack and rods to remove water.
- We believe the well is sound and not an environmental threat.


