Encana Oil & Gas (USA) Inc. (Encana) recently finalized the formation of a 14,262.78 acre Federal exploratory unit named the North Alamito Unit. The North Alamito Unit hearing occurred on June 9, 2016 at the New Mexico Oil Conservation Division in Santa Fe, in which, Encana requested an undivided unit be formed that would also encompass its own unique oil pool designation. The Lybrook P32-2307 01H well, which was approved by the OCD on February 26, 2014, will now be a part of the North Alamito Unit. Encana is submitting this sundry to change the well name from the Lybrook P32-2307 01H to the North Alamito Unit 328H.

Please note, this well was originally permitted under a State APD.




