
E. This exception is requested for the following reasons: **Emergency Flare**

WPX Energy requests a continued authorization to flare the W. Lybrook UT # 748H if a potential cross flow event may occur as a result of a nearby Frac activity on W Lybrook 704H/743H/744H still occurring. If a cross flow event on the well results in nitrogen content above Williams pipeline standards, WPX requests an additional 30 days from our current expiration date of 4/12/17, given approval.

A gas sample will be collected upon the confirmation of the cross flow and sent to a third party for results of the gas analysis. The gas analysis will be submitted upon receipt.


