ConocoPhillips requests permission to temporarily use the Cooper 10 well pad for the mitigation of the residential water well located in 7-27N-11W. A 2" line would be laid from the residential water well to the well pad (~550') above ground. We request permission to vent the gas coming from the water well through the line until a combustor design is finalized and implemented. Once the combustor design is finalized the location would consist of a combustor (currently sizing a 30" X 25' unit), propane tank for fuel gas, RTU/meter, solar panel and battery. The equipment would be fenced for public safety and all equipment is located on lease.
