On 6/17/2017 BP Compliance Specialist Sabre Beebe and BLM Environmental Inspector Randy McKee visited the A. L. Elliott D 006 well as an evaluation for Final Abandonment Approval. The location was found to be stable with appropriate vegetative cover for Final Abandonment. BLM agrees with BP that this location meets all regulatory requirements for FAN and Mr. McKee has agreed to sign off on Final Abandonment of this well pad. A riser belonging to Enterprise pipeline company has been identified to be on the well pad; however authorization for this equipment belonging to Enterprise has been authorized by Jill Aragon with BLM Realty to remain as it is an EOL line.


