Pumped 1664 MSCF of N2, pumped 40,039 gals of 17 CP 70Q Delta with BBC frac fluid. Pumped 112,429 gals of 17 Delta 140 w/BBC Frac fluid. Pumped 1493 sks of 20/40 CRC w/ max BHC. 3-6-12: Recovered 230 bbls with 60% oil cut. 3-9-12: Run in hole with 143 jnts of 2 3/8" 4.7# J55 tbg. Landed tubing 4909". Shut well in 3-12-12: Rig down and move off location.
