- ✓ Comply with current regulations at time of spud  
Prior to production operator needs to be in compliance with RULE 19.15.5.9

The Corrales Canyon Unit hearing occurred on April 14, 2016 at the New Mexico Oil Conservation Division in Santa Fe, in which, Encana requested an undivided unit be formed that would also encompass its own unique oil pool designation. The unit was recently approved with an effective date of April 1, 2014.

The Lybrook P24A-2206 02H well, which was approved by the BLM on December 12, 2015, will now be a part of the Corrales Canyon Unit. Encana is submitting this sundry to change the well name from the Lybrook P24A-2206 02H to the Corrales Canyon Unit 103H.






