PLUG AND ABANDONMENT PROCEDURE

August 21, 2017

Moncrief Federal #1

West Kutz Pictured Cliffs

1450 FNL and 1190' FEL, Section 22, T29N, R12W
San Juan County, New Mexico / API 30-045-08084

- Cut off existing P&A marker. MI and RU.
- Install wellhead. Monitor casing for gas.
- PU drill collar(s) and power swivel. Drill out cement to appropriate depth (top of Kirtland at 470').
- RU Wireline and run CBL from top of drill out to surface.
- Based on CBL review and perforate at appropriate depth and establish circulation.
- If able to establish circulation mix and pump cement to surface; circulating good cement out casing and annulus. SI well and hesitate squeeze until well locks up.
- If unable to establish circulation then Spot Plug to isolate the Kirtland and Ojo Alamo top. WOC and tag.
- Based on CBL perforate 4 squeeze holes at _____. Establish circulation. Spot Plug.
- Mix and pump cement to surface; circulating good cement out casing and annulus.
- SI with pressure and WOC. If cement is at surface set P&A marker. RD and MOL.
- If cement is not at surface then contact operator for further instructions.


