Elm Ridge Exploration Co, LLC reached a TD of 6224' on March 10, 2006. On March 14, 2006 we ran 4-1/2" 10.5 lb J-55 LT&C casing to 6196'. Pumped 1170 sks of 65/35/STD/POZ cement w/ 6% gel. Tailed in w/ 540 sks of 50/50/STD/POZ cement w/ 2% gel. Circulated cement to surface w/ 20 bbls of excess. Pressure tested well to 3200 PSI.
