On September 25, 2017 the Farmington Field Office, Bureau of Land Management conducted a field inspection on the Robinson #2, 990FSL & 990FEL, Section22, T28N. R13W, lease number NM-09979 to evaluate the success of the final reclamation for this well site. According to our records this well was plugged on 1/12/94. The results of our inspection are as follows:

- 1) Cement, debris at P&A marker
- 2) Location not shaped and blended, cut and fill boundaries still evident
- 3) Cement wash on ground to North of location
- 4) No API number on P&A marker
