

WPX Energy requests a continued authorization to flare the **W Lybrook Unit #709H** if a potential cross flow event may occur as a result of a nearby Frac activity on **W Lybrook Unit #716H-718H-719H-753H-754H-755H**. If a cross flow event on the well results in nitrogen content above Williams pipeline standards, WPX requests an additional 30 days from our current expiration date of 11/7/17, given approval.
A gas sample will be collected upon the confirmation of the cross flow and sent to a third party for results of the gas analysis.
The gas analysis will be submitted upon receipt.
