Elm Ridge Exploration CO LLC has drilled a 7 7/8" hole to a TD of 7635' as of 11-10-14. We pressure tested the well to 2300 PSI and held for 30 minutes. Release pressure and bled back 1 bbl of fluid. We have not completed this well. No perforations have been made. We request this well be temporarily abandoned until it is economically feasible to complete and produce this well.
