HPOC seeks to resume the Entrada production of Eagle Springs wells and needs to dispose of produced Entrada formation water into the Entrada formation at the Eagle Springs 9 Federal 1 SWD. HPOC requests permission from the Division to allow the use of the Eagle Springs 9 Federal 1 for a disposal well as part of a 60-day injectivity test. HPOC is currently reconfiguring its SWD facility and seeks to initiate injection upon completion of its current work and upon receipt of permission from the Division. Meanwhile, HPOC shall submit a new C-108 form.



Mr. Mrlik:

Sorry for the delay in responding to your e-mails and phone call. We have been working internally to arrive at a solution to your situation.

I have completed a discussion with staff regarding the expired injection authority for the referenced well. In light of HPOC's effort to resume the Entrada production of the Eagle Springs wells, the Division shall allow the use of the disposal well as part of a **60-day injectivity test**. HPOC will be required to file a notice of intent (Form C-103) with the District III office requesting authority to do so, and receive approval prior to commencing injection. The District will be advised of this allowance.

**During the 60-day period, HPOC will be responsible for submitting a new Form C-108 (Application for Authorization to Inject) for the permanent re-instatement of the authority to inject. Please contact the Engineering Bureau staff (Phillip Goetze or Mike McMillan) with any questions on the application process. The injection authorization will expire at the end of the 60-days if no C-108 application has been filed, or if there are regulatory problems associated with re-instating the permit.**
