Encana Oil & Gas (USA) Inc. (Encana) recently finalized the formation of a 13,128.47 acre Federal exploratory unit named the Blanco Wash Unit. The Blanco Wash Unit hearing occurred on June 25, 2015 at the New Mexico Oil Conservation Division in Santa Fe, in which, Encana requested an undivided unit be formed that would also encompass its own unique oil pool designation. The unit was approved by the BLM on May 31, 2017 with an effective date of August 20, 2012.

The Escrito I24-2409 01H well, which was approved by the BLM on January 20, 2012, will now be a part of the Blanco Wash Unit. Encana is submitting this sundry to change the well name from the Escrito I24-2409 01H to the Blanco Wash Unit 401H.




