13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. BP respectfully requests an additional 60 days from the current 12/19 deadline to run tubing in the subject well. We need to continue gathering well pressure vs production data at rates higher than what is possible through tubing to properly evaluate the reservoir performance of the well using analytical models. Our previous projection was that the well production would decline to a tubing constrained rate by 12/20 without tubing. The well rate has not declined as previously projected so we are requesting an additional extension to continue collecting this data. This additional information will help improve future well, facility and gathering system designs to maximize recovery from the Mancos formation in NEBU.
