Spud well at 7:15 AM on 3/29/06. Drilled 12 1/4" hole to 217' KB. Ran 5 jts of 8 5/8", 24#, LS casing. Casing landed at 208' KB. Cemented with 165 sx (195 cf) of Type 5 cement containing 2% CaCl and 1/4 #/sk cello flakes. Circulated 12 bbls of cement to surface. Pressure tested surface casing and BOP to 500 psi for 30 min. - held OK.
