JOB PROCEDURES

1. MIRU service rig and associated equipment; test BOP.
2. TOOH with 2 3/8" tubing set at 5,758'.
3. Set a 4-1/2" cast iron bridge plug at +/- 3,700' to isolate the ~~Dakota~~ <sup>Mesa Verde</sup> Note: TOC at 2,970' by CBL.
4. Load the hole and pressure test the casing to frac pressure.
5. N/D BOP, N/U frac stack and test frac stack to frac pressure.
6. Perforate and frac the Pictured Cliffs in a single stage (Top Perforation @ 3,516'; Bottom Perforation @ 3,598').
7. Isolate frac stage with a composite bridge plug.
8. Nipple down frac stack, nipple up BOP and test.
9. TIH with a mill and drill out top Pictured Cliffs isolation plug.
10. Clean out to Mesa Verde isolation plug and, when water and sand rates are acceptable, flow test the Pictured Cliffs.
11. Drill out Mesa Verde isolation plug and cleanout to PBTD of 6,044'. TOOH.
12. TIH and land production tubing. Get a commingled Mesa Verde/Pictured Cliffs flow rate.
