Spud 12 1/4" hole on 2/20/06. Run 8-5/8" 24# J-55 csg. Land @ 131', float collar @ 88'. Cement w/95 sx Type 5 cement w/2% CaCl2 w/1/4# celloflake/sx (127 cu ft total). Displace w/5.5 bbls water. Circulate 4 bbls cement. Pressure test csg to 800# 30 mins, held ok.
