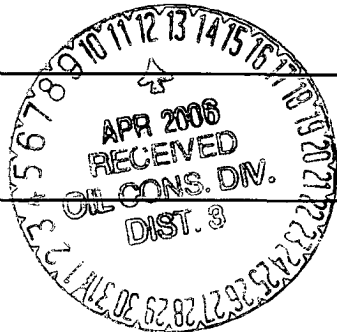

## 13. Describe Proposed or Completed Operations

It is intended to deepen this existing Basin Fruitland Coal well to approximately 3141' - into the Pictured Cliffs formation. It is anticipated the Pictured Cliffs is not productive in this wellbore. The existing tubing and liner will be pulled, the hole will be recavitated, circulated clean, additional footage will be drilled (90' beyond current TD of 3051' or last significant coal) and again the hole will be cleaned and then a reconfigured 5-1/2" 15.5# J-55 liner will be installed from approximately 2818' - 3141'. A mudlogger will be present to insure Pictured Cliffs gas isn't encountered. -P.C. non prod. Sump request granted 4/10/06. GH
