

Operator, Lance Oil and Gas Company, Inc. checked the casing pressure on the NW Cha Cha Unit #24 and found 1250 psig on the casing. Operator requests to temporarily abandon this well, until December 31, 2006, in order to allow Operator to evaluate the entire Cha Cha Unit to determine whether Operator should plug and abandon, return to injection, or to recompleat this well uphole. Operator proposes to Temporarily Abandon the NW Cha Cha Unit #24 by setting a bridge plug within one hundred (100) feet of the uppermost perforations, at 5,070' KB. After setting the bridge plug, Operator will request the presence of a New Mexico Oil Conservation Division and Navajo Tribal agent to conduct a Mechanical Integrity Test on the casing and the bridge plug and report the results promptly.

Your timely concurrence of Operator's request to temporarily abandon the NW Cha Cha Unit #24 would be greatly appreciated as a rig is available and waiting to do this procedure.
