


NOTIFICATION:

- 1. The BLM Minerals Division - Surface Protection Specialist at (970) 385-1242 and the BIA-UMU Agency Realty (970) 565-3716 shall be notified 5 days prior to the onset of pad/road construction.**
- 2. The BIA shall be contacted prior to Ute Mountain Ute surface seeding procedures for specific requirements and seed mixtures. (970) 563-3716.**
- 3. Operator shall hire a third party archeological monitor to be present throughout the life of the reclamation project.**
- 4. Operator shall only use material originally excavated from the trench intended for pipeline burial for reclamation purposes.**
- 5. Operator shall do all work from the shoulder of the access road. No work or disturbance is to take place on undisturbed areas.**
- 6. Operator shall immediately reseed disturbed areas using a BIA approved seed mix.**
- 7. Operator shall crimp mulch a minimum of 3" into the soil to provide for erosive stability.**
- 8. Operator shall complete work prior to May 1st, 2018.**
- 9. Operator will not be afforded additional time to complete reclamation and removal activities.**

10. Operator shall submit pictures as proof of reclamation once operations have been completed.
