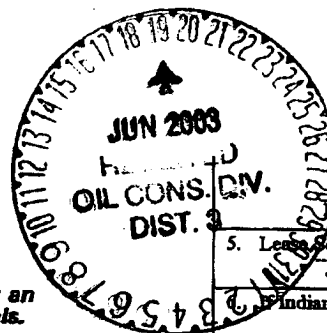

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleat horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. Attach the Bond under which the work will be performed or provide the Bond No. on file with BLM/BIA. Required subsequent reports shall be filed within 30 days following completion of the involved operations. If the operation results in a multiple completion or recompletion in a new interval, a Form 3160-4 shall be filed once testing has been completed. BMG requests permission to temporarily abandon this well for potential use as an inject well. Provided permission is given, BMG will do the following:

- 1) Pull tubing and run back in hole with packer on end of tubing. *→ Dump bail ± 40 ft cut to cover apparent water zone at bottom of open-hole interval.*
- 2) Set packer @ ± 1879' (end of 7" casing @ 1929', open-hole completion 1929-2200'). *2355'*
- 3) Pressure test casing to at least 550# for thirty minutes.

Appropriate NMOC D personnel will be notified at least twenty-four hours prior to testing. Appropriate permission will be obtained prior to initiating the injection.
