Cement with 150 sks Class B, 2% CaCl2, 1/4#/sk flocele (177 cu.ft.). Plug down @ 7:00 pm on 04/17/06. Circulate 10 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
