Cement with 200 sks Class B, 2% CaCl₂, 5#/sk gilsonite, 1/4#/sk floccle tailed by 200 sks Class B, 3% CaCl₂, 1/4#/sk floccle (492 cu.ft.). Plug down @ 7:00 pm on 04/12/06. Did not circulate cement to surface. Ran 1" tubing down backside of casing, tagged cement top @ 208'. RU Halliburton. Cement with 180 sks Class B (212 cu.ft.). Circulate 10 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
