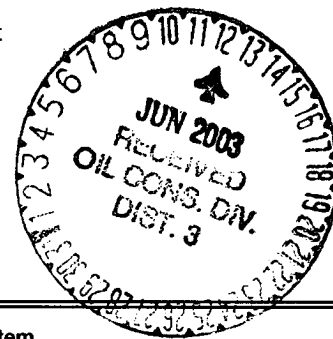

An application is being prepared to convert the Rachel No.2 gas sales meter(El Paso meter No. 89857) to a central delievery meter(CDP) for Dugan's Rachel No.2 & No. 91 wells. The combined production will support the operation of a compressor & will benefit both wells.
