Attached is the MC plat, recomplete procedure, updated schematic and Gas Capture Plan. A DHC application will be filed and approved prior to commingling. A Closed Loop system will be used.

- Notify NMOCD 24hrs prior to beginning operations.
- Set cast iron bridge plug (CIBP) inside of cemented casing and at least 500' below the bottom of the proposed perforations. To show adequate formation/cement isolation.
- Perform and submit a cement bond log (CBL) to the agencies for review and approval prior to perforating the formation.
- If needed, submit proposed remediation to the agencies for review and approval prior to starting remediation.

JOB PROCEDURES

1. MIRU service rig and associated equipment; NU and test BOP.
2. TOOH with 2 3/8" tubing set at 7,297'
3. Set a 4-1/2" cast iron bridge plug at +/- 5,400' to isolate the Dakota.
4. Load hole with fluid and run a CBL on the 4-1/2" casing. Verify cement bond within the Mesa Verde and TOC is above 3,700'. Squeeze cement if needed. (TOC per Temp Survey at 3,715')
5. (If needed) WOC, drill out cement to CIBP. Load casing and run CBL to determine new TOC.
6. RU wireline and perforate the Mesa Verde.
7. TIH with 2-7/8" frac tubing string with packer. Pressure test frac string to frac pressure.
8. N/D BOP, N/U frac stack and test frac stack to frac pressure.
9. Frac the **Mesa Verde** in two or three stages. (Top perforation @ 4,200', Bottom perforation @ 5,300')
10. Nipple down frac stack, nipple up BOP and test. TOOH with frac tubing string and packer and LD.
11. TIH with a mill and clean out to Dakota isolation plug and, when water and sand rates are acceptable, flow test the Mesa Verde.
12. Drill out Dakota isolation plug and cleanout to PBTD of 7,332'. TOOH.
13. TIH and land production tubing. Get a commingled **Dakota/Mesa Verde** flow rate.



**T WELLBORE SCHEMATIC**

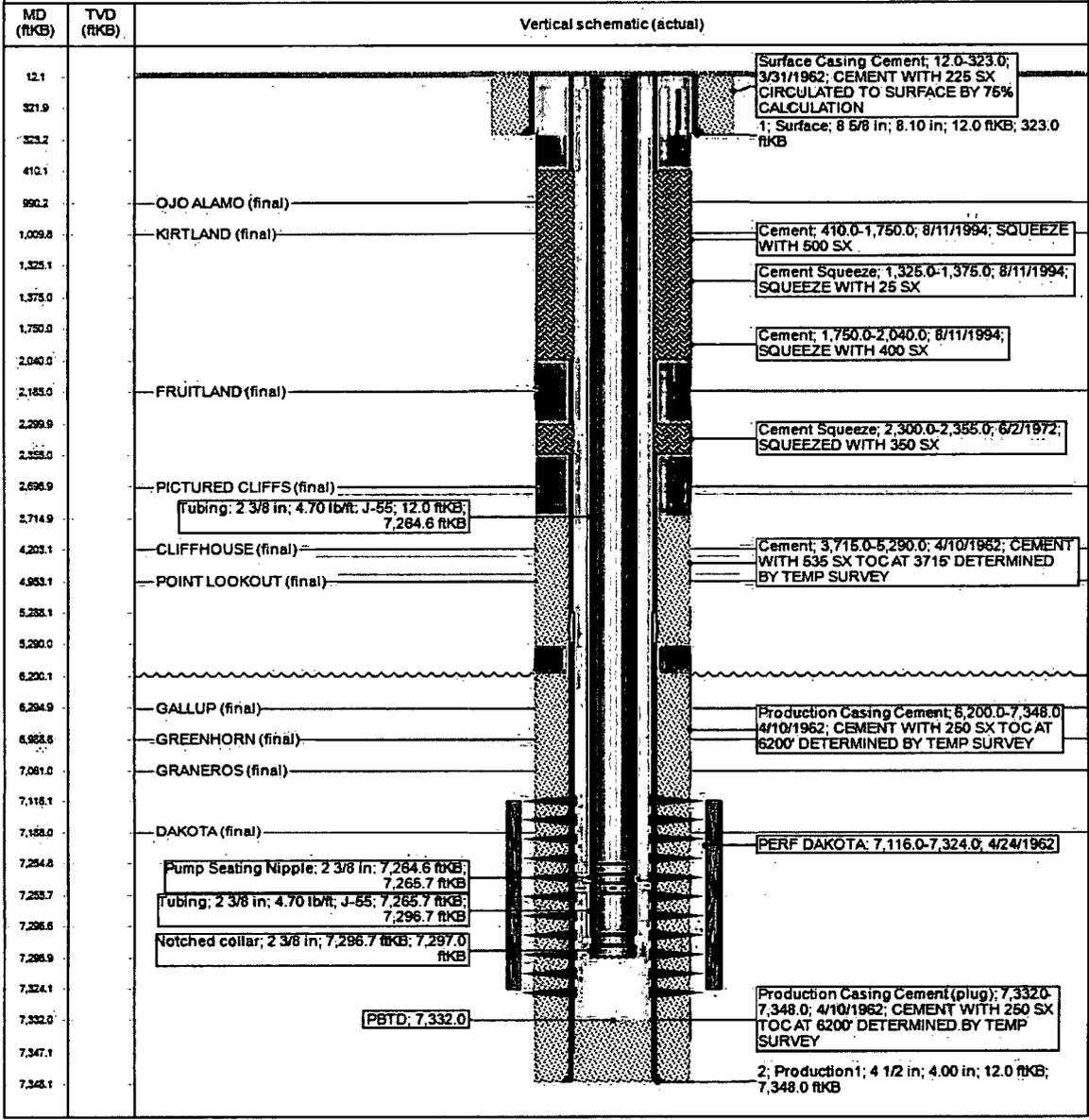
