BMG request permission to temporarily abandon this well for potential use in a tertiary recovery project. Depending on results of the project, the well could be used as an injector or producer. Provided permission is given, BMG will do the following:

- 1) Pull tubing and run back in hole with packer on the end of tubing.
- 2) Set packer @ $\pm 2443'$ (end of $5\frac{1}{2}"$ liner & 3130', top perf @ 2493').
- 3) Pressure test casing to at least 550# for thirty minutes.

Appropriate NMOCD personnel will be notified twenty-four hours prior to testing. Appropriate permission will be obtained prior to using the well as an injector or producer.
