



Cement 2nd stage with 575 sks 65/35 Class C poz, 2% CaCl2, 1/2#/sk flocele, 5#/sk gilsonite, 6% gel followed by 100 sks 50/50 Class C poz, 1% CaCl2, 1/4#/sk flocele, 5#/sk gilsonite, 2% gel (1272 cu.ft.).
