Drill 12-1/4" hole to 295'. On 3/31/03 ran 6 jts 9-5/8" 32.3# H-40 ST&C casing and set at 282'. Cement with 175 sx (36.8 bbls) "B" w/ 2% Cal2, and 1/4# Flocele per sack. Circulate 18 bbls to surface.

Drill 8-3/4" hole to 3112'. On 4/3/03 set 7" 23# J-55 LT&C casing at 3112'. LEAD-cement w/ 500 sx (131 bbls) 50/50 Poz w/ 0.3% gel 5#/sx Gilsonite, 1/4#/sx Flocele, 0.1% CFR-3, and 0.4% Halad 344 TAIL- 50 sx (10.5 bbls) "B" w/ 0.4% Halad 344. Circ 7 bbls cmt

Drill 6-1/4" hole to 3431'. Underream openhole section to 9-1/2". On 4/16/03 ran 77 jts 5-1/2" 15.5# J-55 LT&C casing and set at 3431'. Did not cement this string in well.
