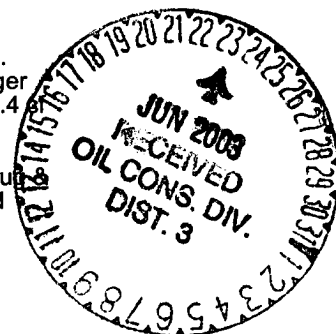

Pumped Lead - 540 sx (1409.4 - 251 bbl slurry) Class G cement w/3% extender, 0.25#/sx Cellophane, 5#/sx Phenoseal, 0.2% Antifoam. Tail - 170 sx (215.9 cf - 38.4 bbl slurry) 50/50 Class G POZ w/2% Gel, 5#/sx Gilsonite, 2.5#/sx Phenoseal, 2% BWOC CaCl₂, 0.25#/sx Cellophane, & 0.2% Antifoam.
