

DJR Operating, LLC requests approval of a postponement of the final reclamation of the Renate Hixon #2 well pad and access road. The well was never drilled, however the pad and access road were both built and graveled.

DJR is currently working with the BLM, State Engineer's office (this site will host the DJR West Carson Water Source well), NMOCD and other agencies on DJR's proposed "Carson Master Development Plan" (CMDP) and is proposing to drill the aforementioned water source well and store frac water at this site for future development in the general area per the CMDP.


Postponement of the reclamation of the well site/access road is contingent on DJR securing approval of and obtaining the necessary permits for the proposed CMDP.
