
Proposed Procedure

2. Test BOP's
3. TOOH with 2-3/8" tubing currently set with EOT at 6,586'
4. Set a CIBP @ 6,440' to isolate the Dakota. Set CIBP @ 2,200' to isolate the PC
5. Load the hole
6. Perforate the Pictured Cliffs from 2,014' to 2,045'.
7. When water and sand rates are acceptable, flow test the Pictured Cliffs
8. Drill out Dakota isolation plug & TOOH
9. TIH and land production tubing. Obtain a commingled Dakota-Pictured Cliffs flow rate
10. ND BOP's, NU production tree
11. RDMO service rig & turn well over to production
