10/13/18- Run 5-1/2" Production Casing. 278 Jts of 5-1/2", 17# P-110, LT&C, csng set @ 11810', FC @ 11770' & 11726', frac initiation sleeve (PBDT) @ 11686'.

10/14/18- Cement 5-1/2 PROD CSG with Halliburton. Cement Summary: Filled lines and pressure tested to 5300 psi. Pumped 60 bbls tuned spacer @ 11.5 ppg. Pumped 172 bbls (505 sks) of lead cement at 12.4 ppg, 1.91 ft3/sk, 9.99 gal/sk H2O. Pumped 400 bbls (1650 sks) of tail cement at 13.3 ppg, 1.36 ft3/sk, 7.54 gal/sk H2O. Dropped 2 top plugs. Displaced with 272 bbls freshwater (First 40 bbls with 1 jug MMCR per tub). (272 actual displacement at 1550 psi/7.9 BPM & pressured up to 1939 psi.) Maintained returns throughout cement job. Circulated 65 bbls of good cement to surface. Floats held, bled back 2 bbls, Top of Tail 2064
