

Cement 2nd stage with 440 sks 65/35 Class B poz, 6% gel, 10#/sk gilsonite, 1/4#/sk flocele, 2% CaCl2 tailed by 145 sks class B, 5#/sk gilsonite, 1/4#/sk flocele (1041 cu.ft.) Plug down @ 2:45 pm on 04/20/06. Circulate 25 bbls cement to surface. RD Halliburton. ND BOP. Released rig @ 6:00 am on 04/21/06. Will test casing during completion.
