Remove CIBP at 6449' and clean out w/ air/mist to TOF at 6587'. Flow test OH section. Mud up wellbore & fish out 1 jt of DP, 2 jts of 4-3/4" DC's & 6-1/8" bit. Clean out OH section to 6794' (TD). Ran 5-1/2", 17#, P-110, Buttress casing as follows: 5-1/2" float shoe, EUE/Buttress X/O, 1jt of 5-1/2" csg, Buttress/EUE X/O, Float Collar, EUE/Buttress X/O, 8jts of 5-1/2", 1ea 20.69' marker jt, and 158jts of 5-1/2" csg and 1ea 20' spacer jt placed 1 full jt from surface. Landed casing at 6793'KB, Float Collar (PBDT) at 6744'KB, Top of 20' marker joint at 6398'KB. Cement casing in place as follows: Pumped 10bbbls water spacer, 10bbl tuned spacer (11.5ppg), 50 sks(68 cf), 12.14bbl, 13.3ppg, Varicem cement. Dropped plug and displaced with 156.5bbls of water, pumped plug to 1840psi, check floats, held good, plug down at 10:10am 09/29/2018. SD while planning completion in Mississippian formation.


