- Because the perforations extend past the bottom of the proposed formation Hilcorp will need to submit a revised Notice of intent (NOI) to include the Mancos formation or resubmit the NOI with revised perforations within the limits of the Mesaverde.
- The Downhole commingle (DHC) will also need to be revised to a trimmingle to include the Mancos or it will need to be revised to include the revised perforations.
- Submit the CBL to the agencies for review and approval prior to any remediation or perforations.

JOB PROCEDURES

1. MIRU service rig and associated equipment; test BOP.
2. TOOH with 2 3/8" tubing set at 8,384'.
3. Set a 4-1/2" plug at +/- 7,140' to isolate the **Dakota**. (Note: TOC at 3,534' by Wellview)
4. RU Wireline. Run CBL. Record Top of Cement.
5. Load the hole and pressure test the casing.
6. N/D BOP, N/U frac stack and pressure test frac stack.
7. Perforate and frac the **Mesa Verde** formation (Top Perforation @ 5,800'; Bottom Perforation @ 6,887').
8. Isolate frac stages with a plug.
9. Nipple down frac stack, nipple up BOP and test.
10. TIH with a mill and drill out top isolation plug and **Mesa Verde** frac plugs.
11. Clean out to **Dakota** isolation plug.
12. Drill out **Dakota** isolation plug and cleanout to PBTD of 8,612'. TOOH.
13. TIH and land production tubing. Get a commingled **Dakota/Mesa Verde** flow rate.
