On 1-29-19, Randy McKee of the BLM-FFO and Paul Lehrman and Steven Merrell of DJR Operating, LLC visited the site. The site has had all surface equipment removed (Pumping Unit, Separator, Meter Run and all above ground facilities associated with the well, along with any underground facilities within the well pad boundaries.

The site has been re-contoured, reseeded and all other specified requirements per the Dome Federal 24 #21 Reclamation Plan as approved by the BLM-FFO.

Per Randy McKee, BLM-FFO AO, the site has been found to comply with the interim requirements under the Reclamation Plan.

Final Reclamation/FAN will be forthcoming as the site meets BLM final reclamation vegetation standards.
