**MV Recompletion Procedure**

2/22/2019

**Procedure:**

1. MIRU Service rig and associated equipment, test BOP.
2. TOOH w/ 2 3/8" tubing set at 6708'.
3. Set initial CIBP at 6535' or deeper (no higher than 50' above existing perforations)
4. Perform MIT from initial CBP, providing 24 hr notice to agencies.
5. *(Note: 5/24/05 CBL shows ~3850' TOC.)*
6. Optionally set bridge plug at approximately 5066'.
7. ND BOP, NU frac stack and test frac stack to frac pressure.
8. Perforate and frac the Mesa Verde. Estimated interval: 4050'-4966' (basal depths are per state rules - 500' below the PTLK top)
9. Cleanout to isolation plug. Flow test MV.
10. Cleanout to PBTD.
11. TIH and land production tubing. Get a commingled flow rate.
12. Release service rig and turn well over to production.
