It is intended to recomplete the subject well in the Blanco Mesaverde (Pool 72319) and downhole commingle with the existing Basin Dakota (Pool 71599). The production will be commingled per Oil Conservation Division Order Number 11363. Allocation and methodology will be provided after the well is completed. Commingling will not reduce the value of the production. The Bureau of Land Management has been notified in writing of this application.

Proposed perforations are: MV: 4453' - 5507' and DK: 7057' - 7285'. These perforations are in TMD.
