DJR Operating is submitting this sundry to move the Surface Hole Location from Section 12, T22N, R6W 1365' FSL 214' FWL formerly known as the L12-2206 to Section 11, T22N, R6W 263'FNL 1130' FEL twinned with the Venado Canyon Unit 207H. This move is within the Venado Canyon Unit on lease and adding the Venado Canyon Unit #206H well head to the Venado Canyon Unit #207 well pad will have no new disturbance from the original approved APD. This SHL move will help DJR Operating LLC increase the length of the lateral for the Venado Canyon Unit 206H drilling from the 207H pad which will help maximize the production lateral length from this well pad.


