Pull & LD polish rod w/liner, 1 ea 6', 1 ea 8'x34" pony rods, 26 ea 3/4" guided rods, 4 ea 1-1/4" sinker bars, no tap tool & 2"x1-1/2"x12' RWAC-Z pump. NDWH. NUBOP. Pull tbg, seating nipple & tail jt w/notch collar. Tally & run 4-1/2" csg scraper & 24 jts 2-3/8" tbg to 774'. Work up & down several times. Pull tbg & csg craper. Shut blind rams. SDFN. On 5/15/2019 held safety meeting. Ran tbg & CIBP, set CIBP @ 738'. LD 1 jt. RU, circ clean w/12 bbls fresh wtr. Press test held 500 psi. Batch mix & pump 60 sks class G cmt @ 15.8# from CIBP to surface. Pull & LD tbg & stinger. NDBOP. Mix & pump 22 sks class G cmt @ 15.8# to top off. RDMOSU.

NMOCD witnessed the press test & cementing.
