The spacing units for both pools (E/2 for Fruitland Coal and SE/4 for Fruitland Sand-Pictured Cliffs) encompass only one federal lease (NM-113433) and all royalty interest is federal. Specifics for downhole commingling are presented in the attached application (NMOCD Form C-103).
